This label appears on every Frontier Bulk Package.

Items always included:

Name of Product, Frontier Item #, UPC, Weight (in grams & ounces), Lot Code based on Packaging Date, "Best Buy Date", Frontier Address, 800#, website, the words -"Non-Irradiated".

Items that appear when applicable:

Botanical Name, Organic Logo, FTC logo, KSA logo, Safety Guidelines, Nutritional Facts, Supplement Facts, Directions & Ingredients.

Green Border Represents NATURAL Product

Red Border Represents ORGANIC Product

KEY

Lot Number: This is a 7-8 digit code used for bulk products. First three or four digits represent Frontier item #. The next four digits represent the date of manufacture. First digit represents the year, following three digits represent Julian date. (i.e. – Lot code of product produced March 9, 2009 would be 9068).

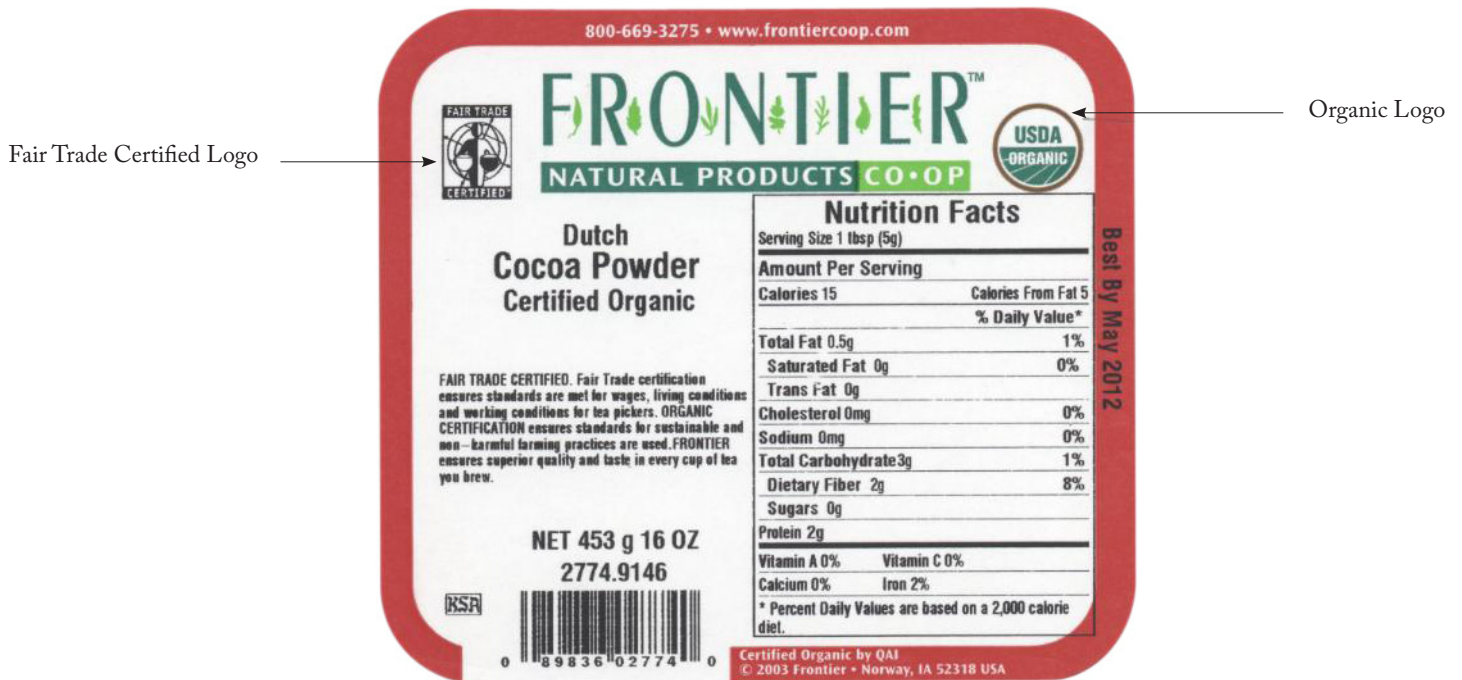
Best By Date: Gives the date that the product is best used by.

Fair Trade Certified Logo: Fair Trade Certified™ (Certified by Transfair USA)

KSA Logo: Kosher Certification

Organic Certification: All of our Organic Products are certified by QAI (Quality Assurance International)

Safety Guidelines: Developed by the American Herbal Products Association (not required to be on label). We choose to put this information on for our customers.



Nutrition Facts: Required by FDA; lists serving size and quantities of nutrients (those nutrients listed in FDA's nutrition regulations) present in the serving size of the food

Supplement Facts: Required by FDA; lists names and quantities of dietary ingredients and serving size

Structure Function Claim: Regulated by FDA; describes role of nutrient or dietary ingredient in structure or function of humans.

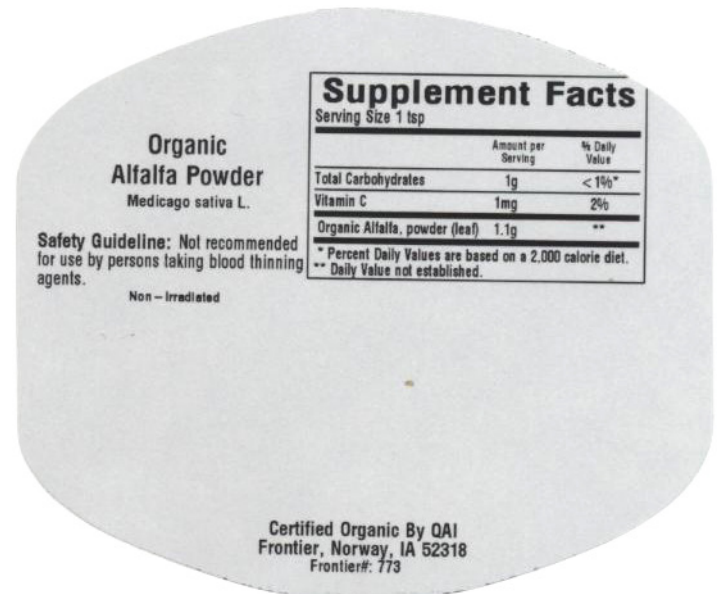
